Post-Construction Services

Types of Construction Projects

Brownroot projects: Projects where construction is to be carried out in or around operating facilities. We have managed shutdowns and have set up permit to work systems to execute the construction works safely.

Grassroot projects: Projects where existing operating facilities do not exist. We have been in involved in the development of the supporting infrastructure (e.g. camps, pipe yards, etc.) at remote sites.
